CLINIC: COUNSELING SERVICES ARE PROVIDED TO ADULTS AGE 55 AND OLDER AT OUR CLINIC, WHICH IS LOCATED IN MANHATTAN AT 302 W 91ST STREET. THE CLINIC OFFERS BOTH OUT-PATIENT SERVICES AND HOMEBOUND SERVICES TO OLDER ADULTS LIVING IN MANHATTAN. MANY OF SPOP'S CLIENTS CAN NOT TRAVEL DUE TO PHYSICAL OR EMOTIONAL FRAGILITY AND SPOP IS ONE OF THE FEW PROGRAMS IN MANHATTAN TO PROVIDE MENTAL HEALTH COUNSELING TO THIS CORE POPULATION.

THE SOCIAL WORKERS AND PSYCHIATRISTS EMPLOYED BY SPOP UTILIZE VARIOUS THERAPEUTIC APPROACHES, INCLUDING THERAPY ORIENTED TREATMENT, PSYCHO-PHARMACOLOGY MANAGEMENT, COGNITIVE, SUPPORTIVE, AND FOCUSED SHORT TERM THERAPY.

4b (Code:) (Expenses \$ 749,700. including grants of \$) (Revenue \$ 857,569.) CDTP: THE CONTINUING DAY TREATMENT PROGRAM PROVIDES SERVICE TO ADULTS AGE 55 AND OLDER WHO ARE SERIOUSLY AND PERSISTENTLY MENTALLY ILL. THIS PROGRAM HELPS OLDER ADULTS WHO ARE UNABLE TO FUNCTION INDEPENDENTLY IN THE COMMUNITY GET THE SERVICES THEY BADLY NEED AS A RESULT OF THEIR SERIOUS MENTAL ILLNESS. FOR THESE CLIENTS SPOP'S CDTP OFFERS HIGHLY STRUCTURED TREATMENT PROGRAMS, WITH A FOCUS ON EACH INDIVIDUAL'S PARTICULAR PSYCHIATRIC NEEDS THROUGH THE PROGRAM'S INTERDISCIPLINARY TEAM, COMPRISED OF SOCIAL WORKERS, CASE MANAGERS, AND A NURSE AND A PSYCHIATRIST WHO PROVIDE AN ENJOYABLE AND SUPPORTIVE ENVIRONMENT FOR THESE OLDER ADULTS WHO NEED A STRUCTURED THERAPEUTIC PROGRAM.

4c (Code:) (Expenses \$ 217,236. including grants of \$) (Revenue \$ 212,787.) SPOP'S GOAL PROGRAM: THE GOAL PROGRAM PROVIDES OUTREACH, ASSESSMENT AND LINKAGE SERVICES. SERVICES AVAILABLE THROUGH THE GOAL PROGRAM ARE INDIVIDUAL COUNSELING AND SUPPORT GROUPS, PSYCHIATRIC CARE AND MEDICATION MANAGEMENT, AND DROP-IN GROUPS AT GEOGRAPHICALLY APPROPRIATE SENIOR CENTER SITE PARTNERS IN THE UPPER EASTSIDE OF MANHATTAN. THIS PROGRAM ALSO PROVIDES LINGUISTICALLY AND CULTURALLY APPROPRIATE MENTAL HEALTH SERVICES TO CLIENTS IN THEIR HOMES OR AT DESIGNATED SENIOR CENTER PARTNER SITES.
