IN ADDITION TO THE PARTICIPANT REVENUE, THIS PROGRAM IS SUPPORTED BY GOVERNMENT CONTRACTS, INCLUDING NYC DEPARTMENT OF HEALTH & MENTAL HYGIENE AND NYC AGING AND PRIVATE FOUNDATIONS.
